REGULATIONS

on the Future Makers: Junior Cup Competition of the Andrey Melnichenko Foundation

1. GENERAL PROVISIONS

- 1.1. These rules set out the goals and objectives of, as well as the procedure and conditions for, the Future Makers: Junior Cup Competition organized by the Andrey Melnichenko Charitable Foundation, abbreviated as FM:JC (hereinafter referred to as the "Competition").
 - 1.1.1. The Competition was established by the Andrey Melnichenko Foundation (hereinafter referred to as the "Foundation") in 2024. The Competition is held with the expert support of its partners: EuroChem JSC, SUEK JSC, Siberian Generating Company LLC, and GRK LLC

1.1.2. Main goal of the Competition:
To engage school and university students in solving real engineering and urban development challenges through direct dialogue with businesses and municipal administrations.

- 1.1.3. Objectives of the Competition:
- To encourage the creative activity of young people interested in scientific and engineering innovation;
 - To promote inventive and project-based work and disseminate methodological tools
- for its support among youth;
- To develop competencies in solving real-world problems requiring scientific and engineering creativity;
- To prepare young people for professional activity in creating new competitive products and technologies.
- 1.1.4. Official languages of the Competition are Russian and English.

2. COMPETITION MANAGEMENT

- 2.1. The organizer of the competition is the Andrey Melnichenko Foundation (hereinafter referred to as "Organizer"). The Organiser announces the Competition and its conditions, forms the Organising Committee, finances the organisation and implementation of the Competition, and provides information coverage of the Competition on the Foundation's website, social media, and in the media
- 2.2. The overall management of the competition is carried out by the organizing committee (hereinafter referred to as the "Committee").

The personal composition of the Organizing Committee is approved by the General Director of the Andrey Melnichenko Foundation.

2.3. The functions of the Committee include:

- Ensuring the organisation and supervision of the Competition;
- Forming the Jury and organising its work;
 Conducting a technical review of preliminary and project applications submitted by participants to ensure compliance with the formal criteria established in these Regulations;

- Awarding the winners and prize-winners of the Competition;
- Preparing proposals for amendments to these Regulations.
- 2.4. The winners and/or prize-winners of the qualifying and final stages of the Competition shall be determined by the Jury, which is formed by the Committee in accordance with Section 6 of these Regulations.

3. PARTICIPANTS OF THE COMPETITION

- 3.1. The competition is open to students from general, secondary vocational, and higher education institutions.
 - 3.2. The following categories of participants are eligible to enter the competition:
 - 3.2.1. Junior Category: Students in grades 5–11 who are citizens of the Russian Federation and study under general education programmes at educational institutions.
 - 3.2.2. Middle Category: Students in their 1st–2nd years of bachelor's and specialist degree programmes at higher education institutions, as well as students in their 1st–4th years of secondary vocational education institutions, aged up to and including 25 years at the time of application; citizens of the Russian Federation and citizens of the countries listed in Appendix No. 9 to these Regulations; students enrolled in bachelor's degree programmes at higher education institutions; and students enrolled in secondary vocational education programmes at secondary vocational education institutions.
 - 3.2.3. Senior Category: Students in their 3rd-6th years of bachelor's and specialist degree programmes at higher education institutions, as well as master's and postgraduate (PhD) students, aged up to and including 25 years at the time of application; citizens of the Russian Federation and citizens of the countries listed in Appendix No. 9 to these Regulations; students enrolled in bachelor's degree programmes and specialist degree programmes at higher education institutions.
- 3.3. The format of the Competition provides for both individual and team participation within the same nominations and age groups. Individual participation means that one participant independently prepares a single solution for one of the selected tasks within the Competition's nominations. Team participation means that a group of participants, united as a team and not exceeding the maximum number of participants established by these Regulations, collectively prepares one solution for one of the selected tasks within the Competition's nominations.
- 3.4. Teams may include a mentor. In such cases, the mentor is considered a member of the team.

The total number of people in a team, including the mentor (if any), must not exceed five (5).

- 3.5. Teams with members belonging to different age groups compete in the older age category corresponding to the oldest team member. The mentor's age is not taken into account when determining the team's age group.
- 3.6. Participation in the Competition is based on a preliminary application (Appendices No. 1, 2, 3 to these Regulations) submitted via the online form on the Competition's website at https://j-cup.fm (hereinafter the "Website") within the timeframe specified in Clause 5.2.1 of these Regulations.
 - 3.7. Each participant submitting a preliminary application must provide consent for the

processing of personal data (hereinafter – "Consent"). The Organiser acts as the data operator for all participants' personal data.

- 3.8. Each participant must review the User Agreement (Consent to Personal Data Processing) and the Privacy Policy available on the Website in the "Documents" section.
- 3.9. Adult individual participants and team members, including mentors, must fill in the preliminary application using the forms provided in Appendices 1 or 3 to these Regulations. Consent to the processing of personal data for adult participants and mentors is collected automatically through the online submission form. Consent is deemed granted when the participant marks the corresponding checkbox (or clicks the corresponding button) in the application form and/or clicks the "Submit" button on any page of the Website.
- 3.10. Minor individual participants and team members, including mentors, must complete the preliminary application using the forms provided in Appendices 2 or 3 to these Regulations. Consent to the processing of personal data for minors is collected in mixed form: the Consent template (Appendix 11 to these Regulations) must be downloaded from the "Documents" section of the Website, filled in and signed by the participant's legal representative (parent, guardian, or custodian), scanned, and uploaded via the submission form on the Website. Consent is considered granted upon completion, signature, and upload of the scanned file to the submission form on the Website.

4. NOMINATIONS AND MAIN STAGES OF THE COMPETITION

- 4.1. The main categories of the competition are:
- 4.1.1. Engineering and technical challenges provided by the competition partners, referred to as the "Engineering Cup";
- 4.1.2. Objectives for urban development and infrastructure improvement formulated by municipal administrations in the Russian Federation, referred to as the "Cities Cup".
- 4.2. Participation process in each nomination of the Competition consists of two main stages:
- 4.2.1. Qualification stage, where the projects and submissions of participants are evaluated based on submitted documents: a project application describing the solution and an accompanying presentation. Following this stage, winners and prize winners are determined in each nomination and age group (listed in Appendix 5 of these Regulations). Winners of the qualification stage become finalists for the Competition and qualify for the next stage;
- 4.2.2. The final stage of the competition, at which the winning projects from the qualifying stage compete and the winners in each category and age group are determined. The list of nominations and age groups can be found in Appendix No. 5 of these Rules. The winners of each nomination in each age group become the winners for that nomination and age group.
- 4.3. All participants of nominations stated in 3.2 of these Regulations are divided into age groups as specified in Appendix No. 5 of these Regulations. Within each age group, participants compete individually or as teams in chosen categonominations of the Competition.

5. COMPETITION PROCEDURE

- 5.1. The announcement of the Competition shall take place on **November,17 2025**.
- 5.2. The Competition shall be conducted in the following order:

- **5.2.1. Stage of submission of preliminary applications** from November,17 2025 to February,1 2026 (until 12:00 Moscow time.
- 5.2.1.1. The Organiser shall publish information about the Competition on the Internet on the Website (including: the Regulations on the Competition, contact information, and other necessary details), as well as on the Foundation's Website, on social networks, and in the mass media.
- 5.2.1.2. Participants shall submit preliminary applications for participation in the qualifying stage of the Competition.
- 5.2.1.3. To submit preliminary applications, participants shall use the preliminary application form (Appendices No. 1–3 to these Regulations) posted on the Website in Russian and English. Preliminary applications shall be submitted in accordance with Clauses 3.6–3.10 of these Regulations.
- 5.2.1.4. Participants who are citizens of the Russian Federation shall complete the preliminary application in Russian.
- 5.2.1.5. Other participants shall complete the preliminary application in Russian or English.
- 5.2.1.6. Preliminary applications for participation in the Competition shall be accepted through the application submission form on the Website https://j-cup.fm.
- 5.2.1.7. All individual participants and participant teams whose preliminary applications were submitted within the established period and meet the formal criteria completeness of the information provided, correct completion of the application form, and the presence of consent to the processing of personal data shall have the right to participate in the Competition.
- 5.2.1.8. The Organising Committee shall have the right, at its sole discretion, to reject preliminary applications that do not meet the formal criteria.
- 5.2.2. Stage of project preparation within the Project School from 15 December 2025 to 1 February 2026.
- 5.2.2.1. Participation in the online course of the Project School (hereinafter also referred to as the "Project School") and preparation of projects describing the proposed solutions for the selected tasks within the Competition nominations shall be carried out in an asynchronous self-directed online format. Individual participants and participant teams shall independently prepare solutions for the selected tasks within the Competition nominations.
- 5.2.2.2. All participants whose preliminary applications have been admitted to participation in the Competition shall be enrolled on the educational online platform "Vovlekay" (hereinafter the "Online Platform") located at https://vovlekay.online/. Enrolment on the Online Platform shall take place no later than 15 December 2025 (until 12:00 Moscow time).
- 5.2.2.3. On the Online Platform, all participants shall complete the online course of the Project School asynchronously in the period from 15 December 2025 to 1 February 2026.
- 5.2.2.4. The purpose of studying the materials of the Project School is to develop the participants' ability to describe and structure the prepared solutions for the selected tasks within the Competition nominations, taking into account the best existing project practices. The result of the work of an individual participant or a participant team in the Project School shall be a **project application** describing the solution and an accompanying **presentation**.
 - 5.2.2.5. The result of completing the Project School shall be the submission of the

prepared documents: a completed full project application and an accompanying presentation. Participation in the Project School shall not be a mandatory condition for participation in the Competition.

- 5.2.2.6. The project application form (Appendix No. 4 to this Regulations) and the requirements for the accompanying presentation (Appendix No. 8 to these Regulations) are published on the Website in Russian and English.
- 5.2.2.7. Individual participants and participant teams who are citizens of the Russian Federation shall complete the project application and prepare the accompanying presentation in Russian. Other individual participants and participant teams shall complete the project application and prepare the accompanying presentation in Russian or in English.
- 5.2.2.8. An individual participant or a participant team shall complete one copy of the project application and prepare one accompanying presentation per individual participant or per team.
- 5.2.2.9. Each adult individual participant or team member, as a personal data subject, shall attach to his or her project application and accompanying electronic presentation a completed and handwrittenly signed Consent to the Processing of Personal Data for Adult Participants (Appendix No. 10 to these Regulations) in a scanned electronic form.
- 5.2.2.10. Each minor individual participant or team member, as a personal data subject, shall attach to his or her project application and accompanying electronic presentation a completed and handwrittenly signed by the legal representative of the personal data subject Consent to the Processing of Personal Data (Appendix No. 11 to these Regulations) in a scanned electronic form.
- 5.2.2.11. Project applications, accompanying presentations, and scanned electronic documents containing Consents to the Processing of Personal Data for participation in the qualifying stage of the Competition shall be accepted by the Organising Committee by email at jcupfm@aimfond.ru.
- 5.2.3. Qualifying Stage of the Competition (stage of evaluation of completed project applications and accompanying presentations) from 2 February 2026 to 1 March 2026.
- 5.2.3.1. The qualifying stage of the Competition shall take the form of a remote evaluation of project applications and accompanying presentations by the Organising Committee and the Jury.
- 5.2.3.2. All project applications and accompanying presentations submitted within the established timeframe (no later than **1 February 2026**) and in accordance with Clause 5.2.2.11 of these Regulations shall be verified by the Organising Committee for compliance with the formal criteria (technical verification of applications): completeness of the information provided, completion of all mandatory fields in the project application, presence of an accompanying presentation, and compliance of the accompanying presentation with the requirements (Appendix No. 8 to these Regulations.
- 5.2.3.3. The technical verification of applications by the Organising Committee shall be carried out during the period from **2 February 2026** to **10 February 2026**.
- 5.2.3.4. The Organising Committee shall have the right, at its sole discretion, to reject applications that do not meet the formal criteria of the technical verification.
- 5.2.3.5. All applications accepted and meeting the formal criteria of the technical verification shall participate in the qualifying stage of the Competition and shall be submitted

to the Jury for evaluation.

- 5.2.3.6. The Jury shall evaluate the project applications and accompanying presentations of participants based on the project evaluation criteria for the qualifying stage of the Competition (Appendix No. 6 to these Regulations).
- 5.2.3.7. The evaluation of project applications and accompanying presentations by the Jury shall take place during the period from 11 February 2026 to 1 March 2026. The announcement of the finalists shall be published on the Website on 4 March 2026.
- 5.2.3.8. Based on the evaluation of all projects participating in the qualifying stage of the Competition, participants of the final stage of the Competition shall be determined in each nomination and age category (Appendix No. 5 to these Regulations) according to the number of points scored as a result of the project evaluation.
- 5.2.3.9. Individual participants and participant teams whose projects have been identified as winners of the qualifying stage of the Competition in the respective nominations and age groups shall proceed to the final stage of the Competition. They shall also receive invitations to the final stage and personalised electronic digital certificates confirming their participation in the finals.
- 5.2.3.10. Individual participants and participant teams whose projects were not identified as winners of the qualifying stage of the Competition shall receive personalised electronic digital certificates confirming their participation in the Competition.

5.2.4. Determination of the Finalists

- 5.2.4.1. Finalists based on the results of the qualifying stage of the Competition shall be determined separately for each nomination within each age group.
- 5.2.4.2. If five or more individual participants or participant teams within a nomination and corresponding age group have achieved the passing score, only the five highest-scoring participants or teams shall be recognised as finalists, provided they have achieved the minimum qualification threshold of 42 points.
- 5.2.4.3. If fewer than five individual participants or participant teams within a nomination and corresponding age group have achieved the passing score, they shall be recognised as finalists. However, if there are no more than three such participants, the final in that age group shall not be held; such participants shall be merged with the next older age group within the same nomination. For the senior age category, participants shall be merged with the middle age category within the same nomination.
- 5.2.4.4. When age groups are merged, a single ranking shall be formed. Based on this ranking, no more than five individual participants or participant teams with the highest scores shall be admitted to the finals.

5.2.5. Final stage of the Competition.

- 5.2.5.1. The final stage of the Competition shall take place in April 2026.
- 5.2.5.2. Participants shall submit the final version of their project presentation to the Organising Committee by 6 April 2026 inclusive by email at jcupfm@aimfond.ru. No revisions shall be accepted after the specified date.
- 5.2.5.3. The exact dates and venue of the final stage of the Competition shall be published on the Website no later than 4 March 2026.
- 5.2.5.4. The final stage of the Competition shall take the form of a contest among projects identified as winners of the qualifying stage of the Competition in the respective nominations and age groups and admitted by the Organising Committee and the Jury to

participate in the final stage.

- 5.2.5.5. The competition of projects shall be held within each age group of each nomination of the Competition (Appendix No. 5 to these Regulations).
- 5.2.5.6. The final stage of the Competition shall be held in the format of **in-person project defences** by individual participants and participant teams.
- 5.2.5.7. The in-person defence of projects at the final stage shall take the form of a final presentation accompanied by an electronic presentation. The total time allocated for the presentation of one project, including discussion and responses to questions, shall not exceed **15 minutes** (presentation up to 10 minutes, discussion and questions up to 5 minutes).
- 5.2.5.8. Each final presentation shall be evaluated by the Jury based on the project evaluation criteria for the final stage of the Competition (Appendix No. 7 to these Regulations.
- 5.2.5.9. In the event of equal scores between evaluated projects, the Jury may, at its discretion, conduct consultations (interviews) with the individual participants and participant teams.
- 5.2.5.10. The winners of the Competition in each nomination and age group shall be the individual participants and/or participant teams who have scored the highest number of points as a result of the evaluation of projects in accordance with the established project evaluation criteria for the final stage of the Competition (Appendix No. 7 to these Regulations).
 - 5.2.5.11. The Jury, with the prior approval of the Organising Committee, shall have the right to:
- 5.2.5.11.1. Recognize as winners of the final stage of the Competition several individual participants and/or participant teams who have scored an equal number of points.
- 5.2.5.11.2. Approve additional nominations of the Competition and the number of participant projects to be awarded in them.
- 5.2.6. The winners and prize-winners of the final stage of the Competition shall be awarded **personalised diplomas and valuable prizes** from the **Andrey Melnichenko Foundation** and the **partners of the Competition**.

6. THE JURY

- 6.1. An independent Jury shall be formed for the evaluation of competition projects submitted by individual participants and participant teams.
- 6.2. The Jury of the Competition shall use the project evaluation criteria for each stage of the Competition (Appendices No. 6 and No. 7 to these Regulations).
- 6.3. The project evaluation criteria for each stage of the Competition may be amended or updated by the Organiser at any time during the Competition, but not later than **31 January 2026**.
- 6.4. For the qualifying stage of the Competition, the Organising Committee shall approve the composition of the Jury from among the employees of the Competition partners and the employees of the Organiser. At the discretion of the Organising Committee, additional Jury members may include representatives of general, secondary vocational and higher education institutions who are not involved in the project work or consultations of the registered participants as mentors, as well as industry experts and practitioners.
 - 6.5. For the final stage of the Competition, the Organising Committee shall approve the

composition of the Jury from among the employees of the Competition partners and the employees of the Organiser. At the discretion of the Organising Committee, additional Jury members may include representatives of general, secondary vocational and higher education institutions who are not involved in the project work or consultations of the registered participants as mentors, as well as industry experts and practitioners.

- 6.6. Mentors of teams shall not be entitled to serve as members of the Jury.
- 6.7. The Jury shall:
- 6.7.1. Carry out an expert evaluation of the projects submitted to the Competition in accordance with the established project themes and the themes of the nominations;
- 6.7.2. Determine the winners and prize-winners of the qualifying stage of the Competition in each nomination and age group in accordance with the project evaluation criteria for the qualifying stage of the Competition (Appendix No. 6 to these Regulations);
- 6.7.3. Determine the winners and prize-winners of the final stage of the Competition in each nomination and age group in accordance with the project evaluation criteria for the final stage of the Competition (Appendix No. 7 to these Regulations).
- 6.8. The Jury's evaluations shall not be disclosed prior to the official announcement of the results.
- 6.9. The results of the Jury's work in evaluating the projects for each nomination and age group shall be formalised in minutes.
- 6.10. After the minutes are drawn up for the qualifying stage of the Competition, the interim results of the Competition shall be summarised (results of the qualifying stage, identification of the winners and prize-winners of the qualifying stage of the Competition in nominations and age groups).
- 6.11. After the minutes are drawn up for the final stage of the Competition, the final results of the Competition shall be summarised (results of the final stage, identification of the winners and prize-winners of the final stage of the Competition in nominations and age groups). The summarising of the Competition results shall take the form of a ceremonial event during which the winners and prize-winners of the final stage of the Competition shall be announced and awarded.
- 6.12. The Organiser, the Organising Committee and the Jury shall not be obliged to respond to any requests for additional expert review submitted by any participants of the Competition or their legal representatives at any stage of the Competition.
 - 6.13. Reconsideration of the evaluations made by the Jury is not provided for.

7. FINANCING OF THE COMPETITION

- 7.1. The financing of the organisation and conduct of the Competition, including the organisation of Competition events, the development, production and duplication of award materials (diplomas, certificates, letters of appreciation, etc.), shall be carried out by the Organiser. The decision regarding encouragement or awarding within the framework of the Competition shall be made at the discretion of the Organiser.
- 7.2. The financing of travel for individual participants and participant teams (the number of members in each team, including the mentor, shall be determined in accordance with Clause 3.3 of these Regulations) to and from the venue of the in-person final stage of the Competition, as well as accommodation and meals during the period of the final stage of the

Competition, shall be carried out by the Organiser. The financing conditions include the following:

- 7.2.1. Travel:
- 7.2.1.1. The Organizer shall pay for tickets for regular bus, rail, or air transport for the trip of an individual participant, a team of participants, including the mentor:
- 7.2.1.1.1. From the railway station, airport, or bus station nearest to the place of residence to the city hosting the in-person final stage of the Competition.
- 7.2.1.1.2. Return travel from the city hosting the in-person final stage of the Competition to the railway station, airport, or bus station nearest to the place of residence.
 - 7.2.1.2. The Organizer shall not pay for:
 - 7.2.1.2.1. Accommodation at intermediate stops during transfers (connecting flights).
- 7.2.1.2.2. Travel to or from the airport, railway station, or bus station from the place of residence and back.
- 7.2.1.2.3. The purchase of new tickets if any of the participants, including the mentor, is late for departure for any reason.
 - 7.2.2. Accommodation:
- 7.2.2.1. The Organizer shall provide accommodation for individual participants and teams, including a mentor, in the city where the final stage of the Competition is held.
- 7.2.2.2. Accommodation shall be paid for strictly on the dates corresponding to the official duration of the final stage of the Competition (hereinafter the "official days of the final stage of the Competition").
- 7.2.2.3. Accommodation outside the specified dates of the final stage of the Competition shall not be provided or paid for by the Organiser.
- 7.2.3. The Organiser shall provide meals for all participants, including the mentor, as part of the events conducted during the official days of the final stage of the Competition.
- 7.2.4. The Organiser shall not cover additional expenses incurred by participants and mentors, including:
 - 7.2.4.1. Personal expenses.
- 7.2.4.2. Transport expenses not related to participation in the in-person final stage of the Competition.
 - 7.2.4.3. The cost of baggage, exceeding the limits established by the carrier.
- 7.2.4.4. Additional services not included in the program of the final stage events of the Competition.

8. COPYRIGHT COMPLIANCE

- 8.1. The Organiser reserves the right to use the competition works of individual participants and participant teams for the purpose of covering the events of the Competition, publishing collections of materials, photo albums, video films, and any other publications about the Competition.
- 8.2. The rights of the authors of the competition works shall be observed in accordance with the legislation of the Russian Federation in the field of protection of intellectual rights.

- 9.1. By submitting an application, the participants confirm their full and unconditional acceptance of these Regulations and all t its provisions without exception.
- 9.2. By submitting an application for participation in the Competition, the participant, acting freely, of his or her own will and in his or her own interest, gives informed and conscious consent to the Organiser (the Andrey Melnichenko Foundation, OGRN 1167700068370, INN 7725335279, KPP 772501001, registered address: 53 Dubininskaya Street, Building 5, Premises VI, Room 6, Moscow 115054, Russian Federation) to process, in documentary and/or electronic form, his or her personal data specified in the application, as well as copies of documents containing information about the aforementioned personal data (if submitted). The processing of personal data and documents containing information about such data shall be carried out by the Organiser for the purposes of organising and publicising the Competition and for subsequent reporting to authorised bodies and donors. Such processing may include collection, systematisation, accumulation, storage, clarification (updating, modification), transfer (including to members of the Organising Committee and the Jury for verification and evaluation of the application), use of the said personal data until the expiration of the retention period of the relevant information or documents containing the aforementioned information, as determined in accordance with the legislation of the Russian Federation, and destruction upon expiration of the period stated. The consent may be withdrawn by the participant in writing by sending a notification by email to contact@aimfond.ru or to the Organiser's registered address: 53 Dubininskaya Street, Building 5, Premises VI, Room 6, Moscow 115054, Russian Federation.
- 9.3. The Organiser shall have the right to amend or supplement these Regulations at any time during the entire period of the Competition. Participants shall independently monitor any possible amendments or additions to these Regulations. Information on amendments or updates to these Regulations shall be published in the "News" section of the official Website no later than 24 hours after the relevant amendments or updates have been made.
- 9.4. The Competition may be cancelled at any stage due to force majeure circumstances and/or termination of funding for the Competition.
- 9.5. The Competition shall be deemed invalid if fewer than three applications meeting all the requirements of these Regulations are registered at any stage of the Competition.
- 9.6. The rights and obligations in the field of personal data protection, in accordance with the provisions of Federal Law No. 152-FZ of 27 July 2006 "On Personal Data", shall be regulated on the basis of the User Agreement (User's Consent to the Processing of Personal Data) and the Privacy Policy published on the Website. The Organiser shall obtain from each registered participant of the Competition the Consent to the Processing of Personal Data (Appendices No. 10 and 11 to these Regulations).

REQUIREMENTS FOR THE DESIGN OF THE ACCOMPANYING PROJECT PRESENTATION IN THE FUTURE MAKERS: JUNIOR CUP OF THE ANDREY MELNICHENKO FOUNDATION

General rules:

Description of the project:

- The presentation should reflect the process of creating, implementing, and analyzing the project.
- Strict adherence to the project's structure, including the problem statement, purpose, objectives, description of the project stages, resources, and results (conclusions).

Presentation Template:

- A unified template is available to all participants on the competition website and in the introductory module of the online course for the project school, which will be published no later than December 15th, 2026.
- Using the template is mandatory for both individual participants and team participants of the Competition.

Volume and structure:

- The presentation should contain no more than 16 slides.
- The first (title) slide should include the following information:
- o The name of the project;
- o Information about the author(s) (full name, education institution, city);
- o The year the project was submitted to the competition.
- The final slide should be a call to action. Example for the Cities Cup "Increase the quality of life for thousands of citizens. Let's implement this solution". Example for the Engineering Cup: "Increase the effects of recourses' usage at your enterprise. Implement our solution!".

Slide numbering:

- Each slide should have a number in the lower right corner.
- The content of the slide (text, images, tables, etc.) should not hide the slide number.

Recommendations for slide design:

Location of information:

- The information should be placed horizontally.
- The main content (text and graphics) should be centered and evenly distributed.

Text:

- Headings should be at least 24 points.
- Main text should be at least 18 points.
- Use a simple, sans-serif font, such as Arial or Calibri).

- It is prohibited to use curved text, shadows, or other decorative effects, such as WordArt. Visual elements:
- Graphic and illustrative materials (photos, drawings, diagrams) should be of high quality and appropriate.
 - Use a variety of slide types: text, images, tables, charts in combination.
 - Avoid overloading slides with information focus on one key message per slide. Color scheme and style:
 - Use no more than three primary colors throughout the presentation.
 - The color of text and background should have sufficient contrast for being readable.
 - Avoid excessive use of animations and slide transition effects.

Additional elements:

- Auxiliary elements, such as navigation buttons, should not distract the viewers from the main content.
 - When using charts and tables, it is important to ensure that:
 - o Diagrams are clear and understandable, with clear labels;
 - o Tables should be minimalistic, with an emphasis on the most important data.

Technical Requirements

File Name:

• The multimedia presentation file name should consist of the Last anme of the individual participant (for individual participants) or the name of the team of participants (for teams of participants) and the full name of the project (for example: Ivanov_EnergyEfficiency.pdf or THE NAME OF THE TEAM EnergyEfficiency.pdf).

File format:

• The presentation should be saved in PDF format to prevent compatibility issues.

File Size:

• The total size of the file should not exceed 25 MB (for the convenience of transferring and downloading).
