

User Consent to the Processing of Personal Data

1. In accordance with the Privacy Policy regarding the processing of personal data published on the website <https://j-cup.fm/> (hereinafter referred to as the *Privacy Policy*), I, the personal data subject, hereinafter referred to as the *User*, by submitting information through registration forms, data collection forms or feedback forms (hereinafter referred to as the *Forms*) for the purpose of using the website <https://j-cup.fm/> (hereinafter referred to as the *Website*), as well as for registration in the **Future Makers: Junior Cup Competition** organised by the **Andrey Melnichenko Charitable Foundation**, hereinafter referred to as the *Competition*, hereby give my full, unconditional and unequivocal **Consent** to the processing of my personal data (hereinafter referred to as the *Consent*) under the following terms and conditions:

1.1. The Consent is granted to the **Andrey Melnichenko Charitable Foundation**, located at 53 Dubininskaya Street, Building 5, Premises VI, Room 6, Moscow, 115054, Russian Federation (hereinafter referred to as the *Operator*).

1.2. The Consent is granted for the processing of personal and other data provided by the User in the Forms by filling in the respective text fields and/or attaching files, of the following general categories:

1.2.1. Surname, given name, patronymic (category: general), date of birth and age (category: general), nationality (category: general), identification document details (category: general), registered address (category: general), actual residential address (category: general), city of residence (category: general), level of education (category: general), e-mail address (category: general), contact telephone number (category: general), and other similar information provided by the User that allows for their identification as a personal data subject.

1.2.2. Data automatically transmitted during browsing or visiting the Website pages, including: IP address, cookies information, browser details, access time, page address visited, referrer (address of the previous page), and statistics concerning IP addresses.

1.3. The Consent is granted for the processing of personal data for the following purposes:

1.3.1. Registration for participation in the Competition;

1.3.2. Providing access to the Website (its content and functionality), including for Website administration and improving its performance;

1.3.3. Obtaining feedback, including sending notifications and requests, and providing information about the Operator's activities and events;

1.3.4. Collection of statistical data by the Operator.

2. The User hereby acknowledges, is informed of, and agrees that for the purposes stated above, the Operator is entitled to collect and use additional information related to the User obtained during the User's access to the Website and its content or from third parties, to manage statistical data related to the Website's operation, as well as to use the User's information for the purposes of ensuring the functioning and technical support of the Website and/or its services, and for compliance with the laws of the Russian Federation and the Privacy Policy developed thereunder.

3. The Consent is granted for the mixed processing of personal data. During the processing of personal data, the Operator is entitled to perform the following actions: collection, recording, systematisation, accumulation, storage, clarification (updating,

modification), retrieval, use, transfer (distribution, provision, access), anonymisation, blocking, deletion, and destruction of the User's personal data.

4. The User hereby confirms that:
 - 4.1. They are informed of and agree that the transfer of their personal data may be carried out by the Operator to the extent necessary to provide the User with access to the Website and its content.
 - 4.2. They are informed of the possibility to withdraw the Consent in accordance with Federal Law No. 152-FZ "On Personal Data" of 27 July 2006 by submitting a personal request via e-mail to: **contact@aimfond.ru**, including being informed of their right to withdraw the Consent either for all personal data specified in clause 1.2 hereof or for part thereof.
 - 4.3. They are informed that the Operator has the right to continue processing the User's personal data after receiving the withdrawal of the Consent or after its expiration, if such grounds are provided for in Part 2 of Article 9 of Federal Law No. 152-FZ "On Personal Data" of 27 July 2006.
5. The Consent may be withdrawn by the User by submitting a written statement in free form to the Operator's e-mail address **contact@aimfond.ru**, or by any other means that unambiguously confirms its receipt by the Operator.
6. The Consent remains valid for an indefinite period until it is withdrawn by the User. The Consent shall terminate on the date specified in the User's withdrawal statement, but not earlier than the day following the actual receipt of such withdrawal by the Operator.
7. In the event that the Consent is granted in an automated form, the date and time of its creation, confirmation, and submission shall be considered the moment when the corresponding checkbox (or button) in the Form is marked and/or the submission button on any page of the Website is clicked.
8. In the event that the Consent is granted in mixed form, the date and time of its creation, confirmation, and submission shall be considered the moment when the **Consent to the Processing of Personal Data** template is completed and signed, and subsequently submitted to the Operator by uploading a scanned copy of the Consent via the Website form or by sending it to **contact@aimfond.ru**.
9. The User is informed that the Operator shall bear responsibility for the actions of any person processing the User's personal data on behalf of the Operator.
10. The User may obtain any clarifications regarding the processing of their personal data by contacting the Operator via e-mail at **contact@aimfond.ru**.
11. Any changes to the Operator's personal data processing policy shall be reflected in this document. The Consent remains valid indefinitely until it is replaced by a new version.
