Rules

for the Future Makers: Junior Cup Competition of the Andrey Melnichenko Charitable Foundation

1. GENERAL PROVISIONS

- 1.1. Thes rules set out the goals and objectives of, as well as the procedure and conditions for, the Future Makers: Junior Cup Competition organized by the Andrey Melnichenko Charitable Foundation, abbreviated as FM:JC (hereinafter referred to as the "Competition").
- 1.2. The Competition was founded by the Andrey Melnichenko Charitable Foundation in 2024 and is supported by the expert partners of the competition, JSC "MHC "EuroChem", JSC "SUEK" and LLC "Siberian Generating Company", as well as the League of Foundations from the BRICS+ countries. The goal of the competition is to promote activities in education and science, including identifying and developing talented young people in the fields of natural science research, design, and engineering.
 - 1.3. The main purpose of the Competition:
- 1.3.1. Development of educational infrastructure and support for initiatives to achieve sustainable development goals.
 - 1.4. The main objectives of the Competition:
- 1.4.1. Stimulating the creative activity of young people interested in science and engineering;
- 1.4.2. Popularizing inventive and design activities among young people and disseminating methodological tools for supporting them;
- 1.4.3. Forming competencies for solving real-world problems requiring scientific and engineering ideas;
- 1.4.4. Preparing young people for professional work in the field of creating new products and technologies..
 - 1.5. The official languages of the Competition are Russian and English.

2. COMPETITION MANAGEMENT

- 2.1. The organizer of the competition is the Andrey Melnichenko Charitable Foundation (hereinafter referred to as "Organizer"). The Organizer announces the competition and the conditions for its conduct, forms an organizing committee, finances the organization and conduct of the competition, and covers the competition on the foundation's website, social media, and the media.
- 2.2. The overall management of the competition is carried out by the organizing committee (hereinafter referred to as the "Organizing Committee").

The personal composition of the Organizing Committee is approved by the General Director of the Andrey Melnichenko Charitable Foundation.

- 2.3. The functions of the Organizing Committee are:
- 2.3.1. Ensuring the successful holding of the competition and monitoring its progress;
- 2.3.2. Forming the jury and organizing its work;
- 2.3.3. Checking the preliminary and project submissions of participants for compliance

with the formal criteria set out in this Rules;

- 2.3.4. Awarding the winners and prize winners of the competition;
- 2.3.5. Forming proposals to amend this provision.
- 2.4. The winners and prize-winners of the qualifying and final stages of the competition are determined by a jury, which is appointed by the Organizing Committee in accordance with Section 6 of these Rules.

3. PARTICIPANTS OF THE COMPETITION

- 3.1. The competition is open to students from general, secondary vocational, and higher education institutions.
 - 3.2. The following categories of participants are eligible to enter the competition:
- 3.2.1. Pupils from grades 5-11 who are citizens of the Russian Federation and study in general education institutions according to basic general and secondary general educational programs;
- 3.2.2. Students from 1st to 4th courses who are citizens of the Russian Federation or countries listed in Appendix No.7 to these Rules and study at secondary vocational educational institutions according to secondary vocational programs;
- 3.2.3. Bachelor's degree students from 1st to 4th years who are either citizens of the Russian Federation or citizens of countries included in Appendix No.7 who study at institutions of higher education;
- 3.2.4. Students of the first to sixth courses, citizens of the Russian Federation, studying in institutions of higher education in accordance with specialty programs.
- 3.3. The format of the competition involves both individual and team participation. Individual participation means that each participant of the competition independently prepares one solution to one of the selected tasks within the scope of the competition's categories and subcategories. Team participation involves a group of participants united as a team, not exceeding the maximum number of members set, collectively preparing one solution to one selected task within the same categories and subcategories of the competition. Team participation can include a mentor, who would then be considered a member of the team. The maximum number of people in a project team is five, including a mentor if the team chooses to have one. Teams with a mixed age range of participants participate in the competition in the oldest age group, which one of their team members belongs to.
- 3.4. The basis for participation in the competition is a preliminary application submitted via the online form on the competition website https://j-cup.fm within the timeframe specified in clause 5.2.1 of these Rules. The application should include the necessary documents specified in Appendices 1, 2 and 3 of these Rules.
- 3.5. Each participant of the competition who submits a preliminary application to participate in the event must provide their consent for the organizer to process their personal data (hereinafter referred to as "Consent"). The organizer of the competition is the operator of the personal data of all participants.
- 3.6. Each participant in the contest must independently read and understand the User Agreement and Privacy Policy, which are posted on the contest website at https://j-cup.fm in the "Documents" section.
 - 3.7. Adult individual participants and team members of the Competition complete a

preliminary application to participate in the Competition using the forms specified in Appendix No. 1 or Appendix No. 3 of this Rules. The Operator collects consent to the processing of personal data from adult individual participants and team members at the time of submitting the preliminary application in an automated manner. The participant grants their consent by checking the appropriate box (or clicking the appropriate button) on the form for submitting the preliminary application for participating in the Competition. If consent is granted in an automated way, then the date and time that consent was given is considered to be when the appropriate box was checked (or button clicked) on the form, and/or when the form was submitted on any page of the website.

3.8. Underage individual participants and members of the Competition teams (including mentors) submit a preliminary application to participate in the Competition using the forms specified in Appendixes No. 2 or 3 of this Rules. The Operator collects consent to the processing of personal data from underage individuals and team members in a mixed manner during the submission of a preliminary application. The participant, the subject of the personal data, provides their consent by completing and signing the consent form, which is submitted by their legal representative or representative of the participant. The completed and signed consent is submitted by uploading a scanned copy of the consent document via the preapplication form on the Competition website. 11 to this Rules) posted on the Website The competition https://j-cup.fm in the "Documents" section. If you agree to participate in the competition in a mixed manner, the date and time of your consent is considered to be the moment when you fill out and sign the Consent template for processing personal data and transfer it to the Operator by uploading a scanned consent file through the form on the website.

4. THE CATEGORIES OF THE COMPETITION. THE MAIN STAGES OF THE COMPETITION

- 4.1. The main categories of the competition are:
- 4.1.1. Engineering and technical challenges provided by the competition partners, referred to as the "Engineering Cup";
- 4.1.2. Objectives for urban development and infrastructure improvement formulated by municipal administrations in the Russian Federation, referred to as the "Cities Cup".
- 4.2. The process of participating in each of the categories of the Competition involves two main stages:
- 4.2.1. The selection stage, where the projects and submissions of participants are evaluated based on submitted documents: a project application describing the solution and an accompanying presentation. Following this stage, winners and prize winners are determined in each category, subcategory, and age group (listed in Appendix 5 of this Rules). Winners of the selection stage become finalists for the Competition and qualify for the next stage;
- 4.2.2. The final stage of the competition, at which the winning projects from the qualifying stage compete and the winners in each category and age group are determined. The list of categories and age groups can be found in Appendix No. 5 of these Rules. The winners of each category in each age group become the winners for that category and age group.
- 4.3. All participants are divided into age groups as specified in Appendix No. 5. Within each age group, participants compete individually or as teams in selected categories and subcategories of the competition.

5. THE STAGES OF THE COMPETITION

- 5.1. The competition will be announced on November 22nd, 2024.
- 5.2. The competition will take place in the following stages:
- 5.2.1. Stage 1: Submission of preliminary applications, which will be accepted from November 22, 2024 until January 14, 2025, at 12:00 Moscow time.
- 5.2.1.1. The Organizer will post information about the Contest on the internet, on the website The competition https://j-cup.fm (including: The Competition Rules, contact details and other necessary information), as well as on the Foundation's website, social media platforms and other media outlets.
- 5.2.1.2. Participants submit preliminary applications to take part in the qualifying stage of the competition.
- 5.2.1.3. To submit preliminary applications, participants use the preliminary application form (Appendices No. 1-3 to these Rules) posted on the Competition Website https://j-cup.fm in Russian and English. Preliminary applications are submitted in accordance with paragraphs 3.4-3.8 of these Rules.
- 5.2.1.4. Participants who are citizens of the Russian Federation fill out a preliminary application in Russian.
 - 5.2.1.5. Other participants fill out a preliminary application in Russian or English.
- 5.2.1.6. Preliminary applications for participation in the Competition are accepted through the application form on the Competition Website https://j-cup.fm.
- 5.2.1.7. All individual participants and teams have the right to take part in the competition, whose preliminary entries were submitted within the specified time frame and meet the specified criteria: completeness of information provided, accuracy of filling out the application form, and consent to the processing of personal data.
- 5.2.1.8. The organizing committee has the right to unilaterally reject entries that do not meet these criteria.
- 5.2.2. **Stage 2: Project preparation, within the Project School framework.** from January 15, 2025 to February 15, 2025.
- 5.2.2.1. Participation in the online course of the Project School and the preparation of projects to describe the proposed solutions for the selected tasks of the Competition will be carried out in an asynchronous, independent online format. Individual participants and groups of participants will independently prepare solutions to the selected tasks.
- 5.2.2.2. All participants whose preliminary applications have been admitted to the Competition must enroll in the online learning platform Engage located on the website https://vovlekay.online/. Enrollment in the platform must be complete by January 15, 2025 (no later than 12:00 Moscow time).
- 5.2.2.3. On the online platform, "Vovlekay", participants will take an online course from January 15 to February 15 in the asynchronous format.
- 5.2.2.4. The purpose of the participants' study of the Project School materials is to develop their ability to describe and package solutions for selected tasks within the Competition. Participants will learn about best practices in project work and create a project application and presentation that describes their solution.
- 5.2.2.5. To be eligible for admission to the competition, an individual participant or a team of participants must complete the online course offered by the Project School. This

includes completing all tasks assigned during the course and studying the materials provided by the Project School. The completion of the final test and submission of all required documents, including a completed project application and accompanying presentation, is mandatory.

- 5.2.2.6. The project application form (Appendix No. 4 to this Rules) and guidelines for creating the accompanying presentation can be found on the Competition website at https://j-cup.fm in both Russian and English.
- 5.2.2.7. Individual participants and teams of Russian citizens complete a project application and prepare an accompanying presentation in Russian. Non-Russian participants can also complete the application and presentation in either Russian or English.
- 5.2.2.8. Each individual participant or team of participants submits one completed project application and accompanying presentation.
- 5.2.2.9. Each adult participant or team member who is a subject of personal data must attach a completed and signed Consent to the processing of their personal data for the adult participants (Appendix 10 of this Rules) to their project application and electronic presentation in a scanned electronic format.
- 5.2.2.10. Each minor participant or team member who is the subject of personal data should attach a completed hand-signed consent to the processing of the legal representative's personal data (Appendix 11 of this Rules) to the project application and the accompanying electronic presentation in a scanned electronic form.
- 5.2.2.11. Project applications, electronic presentations, and scanned electronic forms of consents to the processing of personal data for participating in the qualifying phase of the competition will be accepted by the organizing committee via email at jcupfm@aimfond.ru.
- 5.2.3. Qualifying stage: Evaluation of completed project applications and presentations, from February 16 to March 7, 2025.
- 5.2.3.1. The selection stage of the competition will be conducted thanks to the evaluation of project proposals and accompanying presentations by the organizing committee and the jury, without interaction with the participants.
- 5.2.3.2. All project proposals submitted within the specified timeframe (no later than February 15th, 2025), in accordance with clause 5.2.2.9 of these Rules, will be reviewed by the organizing committee to ensure compliance with formal requirements (technical verification). This includes checking for completeness of information provided, ensuring that all mandatory fields on the project proposal are filled out, verifying the availability of an accompanying presentation, and ensuring that the presentation is registered in accordance with the specified requirements (Appendix 8 of these Rules). Additionally, it will be verified that the applicant has completed the online coursework for the Project School and fulfilled all tasks assigned.
- 5.2.3.3. The technical verification of applications by the Organizing Committee will take place between February 16 and February 23, 2025.
- 5.2.3.4. The Organizing Committee reserves the right to reject applications that do not meet formal criteria for technical verification.
- 5.2.3.5. All accepted applications meeting the formal criteria will participate in the qualifying round of the competition and be submitted to the jury for evaluation.
- 5.2.3.6. The jury will evaluate project applications and accompanying presentations based on criteria for evaluating projects in the qualifying phase of the competition (see Appendix 6 of these Rules).

- 5.2.3.7. Evaluation of technically compliant project applications will take place from February 24 to March 7, 2025, by the jury.
- 5.2.3.8. As a result of the evaluation of all projects participating in the qualifying round of the Competition, the winning and prize-winning projects for the qualifying round are determined. The winners and runners-up in each nomination and age category (see Appendix No. 5 of these Rules) are selected based on the number of points earned as a result of the project evaluation.
- 5.2.3.9. Individual participants and teams of participants whose projects were determined as **winners** of the qualifying stage of the Competition in categories, sub-categories and age groups go through to the final stage of the Competition, as well as receive invitations to the final stage of the Competition and personal electronic digital certificates confirming participation in the Competition and a place in the qualifying stage of the Competition.
- 5.2.3.10. Individual participants and teams of participants whose projects were determined not as winners, but as prize-winners of the qualifying stage of the Competition in nominations, nominations and age groups receive personalized electronic digital certificates confirming participation in the Competition and a place in the qualifying stage of the Competition.

5.2.4. Final stage: Award ceremony and announcement of winners.

- 5.2.4.1. The final stage of the Competition will be held in April 2025.
- 5.2.4.2. The final stage of the competition will take place in April 2025. The exact dates and location of the final event will be announced on the competition website https://j-cup.fm no later than March 7, 2025.
- 5.2.4.3. Only projects that have been selected as winners in the qualifying rounds of the competition and have been approved by the organizing committee and jury will be allowed to participate in the finals.
- 5.2.4.4. Each age group within each category of the competition (as specified in Appendix No. 5 of these Rules) will have its own project competition.
- 5.2.4.5. The competition at the final stage will take place in the form of face-to-face presentations by individual participants and teams.
- 5.2.4.6. At the final stage of the competition, live protection of projects takes place in the form of a presentation accompanied by a final report. Each presentation is limited to 15 minutes, including up to 10 minutes for the actual presentation and up to 5 minutes for discussion and answering questions.
- 5.2.4.7. The final report of each project will be evaluated by the jury according to the criteria listed in Appendix No. 7.
- 5.2.4.8. In case of a tie, the jury may choose to conduct consultations or interviews with individual participants or teams to break the tie if necessary.
- 5.2.4.9. The winners in the given category and age group are the individual participants or team of participants who achieved the highest score based on the evaluation of their project according to the criteria set at the final stage of the competition. (See Appendix No.7 of these Rules for more details.)
 - 5.2.4.10. The Jury, by prior agreement with the Organizing Committee, has the right:
- 5.2.4.10.1. To recognize as the winners of the final stage of the Competition several individual participants and/or teams of participants who scored an equal number of points.
 - 5.2.4.10.2. To approve additional nominations of the Competition and the number of

projects awarded to participants in them.

5.2.5. The winners of the final stage of the Competition are awarded with personal diplomas and valuable prizes from the Andrey Melnichenko Charitable Foundation, as well as the partners of the Competition.

6. THE JURY

- 6.1. An independent jury will be formed to evaluate the competitive projects submitted by individual participants and teams.
- 6.2. The Jury will use the criteria for project evaluation for each stage of the competition (Appendices 6 and 7 of these Rules).
- 6.3. The Organizer may change or update the criteria for each stage at any time during the competition, but not later than January 31st, 2025.
- 6.4. For the qualifying stage of the Competition, the Organizing Committee will approve the composition of the jury, which can include employees of partners of the Competition and employees of the Organizer. Additionally, representatives of educational organizations, such as general, secondary vocational and higher education institutions, who are not directly involved in the work of the declared participants, can be invited as additional members of the jury. These representatives may act as mentors or experts in their respective fields. The decision to invite them is at the discretion of the Organizing Committee.
- 6.5. For the final stage of the competition, the organizing committee will approve the composition of the jury consisting of employees of the competition partners and the organizer. Representatives of educational institutions of general, secondary vocational, and higher education who have not been involved in the project work or consultations with the declared participants, as mentors or industry experts, may be invited as additional jury members at the discretion of the organizing committee.
 - 6.6. Mentors are prohibited from being part of the jury.
 - 6.7. The Jury will carry out:
- 6.7.1. Expert assessment of the projects submitted for the Competition in accordance with the established topics of projects, themes of nominations and categories;
- 6.7.2. Determination of the winners and prize winners of the qualifying stage of the Competition in each nomination, category and age group according to the criteria for assessing projects for the qualifying stage (Appendix No. 6 of these Rules);
- 6.7.3. Selection of winners for the final round of the competition based on the criteria for assessing final round projects (Appendix 7 of these Rules).
 - 6.8. The jury's scores are not disclosed until the official announcement of the results.
- 6.9. The results of the jury's work in the competition for the evaluation of projects in each category, subcategory, and age group are recorded in protocols.
- 6.10. After the protocols have been completed at the preliminary stage of the competition, the intermediate results of the competition are summarized (the results of the preliminary stage, the winners and finalists of the preliminary stage in categories, subcategories, and age groups).
- 6.11. After the protocols have been drawn up at the final stage of the competition, the results of the competition are summarized. This includes the results of the final stage, the winners in each category and age group. The results are announced during a special ceremony,

where the winners are presented with their awards.

- 6.12. The organizer, organizing committee, and jury have the right to refuse requests for additional information or expertise from any participant or their representatives at any point during the competition.
 - 6.13. No reconsider of the jury's decisions is provided.

7. FINANCING OF THE COMPETITION

- 7.1. The Organizer is responsible for financing the organization and hosting of the competition, including the arrangement of competition events, the production and distribution of awards (diplomas, certificates, letters of appreciation, etc.). The decision to award prizes within the framework of the competition is at the discretion of the organizer.
- 7.2. The Organizer will cover the costs of travel for individual competitors and teams (the number of members per team, including a coach, is specified in clause 3.3 of these Rules) to attend the final in-person stage of the competition. This includes transportation to and from the location, accommodation, and meals during the duration of the in-person competition. The terms of financing include:
 - 7.2.1. Travel:
- 7.2.1.1. The Organizer shall pay for tickets for regular bus, rail, or air transport for the trip of an individual participant, a team of participants, and a mentor:
- 7.2.1.1.1. From the nearest railway station, airport, or bus station to the city where the final live stage of the competition will take place.
- 7.2.1.1.2. Back from the city where the competition's final stage is held to the nearest railway station, airport, or bus terminal.
 - 7.2.1.2. The Organizer will not pay for:
 - 7.2.1.2.1. Accommodation at intermediate stops during transfers (connecting flights).
- 7.2.1.2.2. Travel from the participant's place of residence to the airport, railway station, or bus stop before departure, and back after return.
- 7.2.1.2.3. Purchase of new tickets for any participant, including the mentor, who is late for departure for any reason.
 - 7.2.2. Accommodation:
- 7.2.2.1. The Organizer will provide accommodation for individual participants and teams, including a mentor, during the final stage of the competition in the specified city.
- 7.2.2.2. Accommodation will be provided only on the days that coincide with the official dates of the final stage (hereinafter referred to as the "official days of the competition").
- 7.2.2.3. Accommodation outside these official days will not be provided and will not be paid for by the Organizer.
- 7.2.3. Meals will be provided to all participants, including the mentor, during events held on official days.
- 7.2.4. The Organizer will not cover any additional expenses for participants or the mentor, such as:
 - 7.2.4.1. Personal expenses.
- 7.2.4.2. Transportation costs that are not directly related to their participation in the competition.

- 7.2.4.3. The cost of excess baggage, which exceeds the baggage allowance set by the carrier.
- 7.2.4.4. Additional services not included in the program of the final event of the competition.

8. COPYRIGHT COMPLIANCE

- 8.1. The Organizer reserves the right to use the works submitted by individual participants and teams for coverage of the events of the Competition and publication of collections of materials, photo albums, videos, and any other publications related to the Competition.
- 8.2. The rights of authors of competition works will be respected in accordance with the laws of the Russian Federation on intellectual property protection.

9. OTHER

- 9.1. By submitting an application, the participants confirm their full and unconditional acceptance of these Rules and all their clauses without exception.
- 9.2. By submitting an application for the competition, the participant freely and voluntarily gives informed and conscious consent to allow the Organizer (Andrey Melnichenko Charitable Foundation (OGRN 1167700068370, TIN 7725335279, checkpoint 772501001) located at: 53 Dubininskaya str., p. 5, Moscow, 115054, VI, com. 6), to process their personal data in written and/or electronic forms as specified in the application. This also includes any copies of documents that may contain information about the applicant's personal data if they are submitted. The processing of personal data and documents containing information about the participants is carried out by the Organizer for the purposes of conducting and covering the competition and subsequent reporting to authorized bodies and donors. This processing may include the collection, systematization, accumulation, storage, updating (changes), transfer (including to members of the organizing committee and the jury), verification and evaluation of applications, use of the personal data specified before the expiration of the relevant storage period, and destruction of the data after the specified period, in accordance with the requirements of the legislation of the Russian Federation. Consent may be withdrawn by a participant by sending a written notification via email to contact@aimfond.ru or by mail to the address of the organizer's location: 115054, Moscow, 53 Dubininskaya Street, room VI, No. 6.
- 9.3. The Organizer reserves the right to make changes and additions to these Rules at any time during the duration of the Competition. Participants are responsible for monitoring any potential changes or additions to the Rules. Information regarding changes or updates will be posted in the "News" section of the official Competition website https://j-cup.fm within 24 hours of any relevant changes or updates.
- 9.4. In the event of force majeure or termination of funding for the Competition, the Competition may be cancelled at any stage.
- 9.5. The Competition will be considered invalid if fewer than three entries have been submitted at any point during the Competition that comply with all requirements of these Rules.

9.6. The rights and obligations related to personal data protection, in accordance with Federal Law No. 152-FZ of July 27, 2006, "On Personal Data", are governed by the terms of the User Agreement and the Privacy Policy posted on our website at https://j-cup.fm. The Organizer obtains consent from each registered contestant to process their personal data (see Appendices 10 and 11 of these Rules).

General rules:

Description of the project:

- The presentation should reflect the process of creating, implementing, and analyzing the project.
- Strict adherence to the project's structure, including the problem statement, purpose, objectives, description of the project stages, resources, and results (conclusions).

Presentation Template:

- •A single template will be made available to all participants on the competition website and in the introductory module of the online course for the project school, which will be published no later than January 15th, 2025.
- The use of this template is mandatory for both individual participants and team participants in the competition.

Volume and structure:

- The presentation should contain no more than 16 slides.
- The first (title) slide should include the following information:
- The name of the project;
- o Information about the author(s) (full name, education institution, city);
- o The year the project was submitted to the competition.
- The final slide should be a phrase of gratitude to the audience, (for example, "Thank you for your attention!").

Numbering:

- Each slide should have a number in the lower right corner.
- The content of the slide (text, images, tables, etc.) should not cover the slide number.

- The main content (text and graphics) should be centered and evenly distributed.

- Headings should be at least 24 point size.
- Main text should be at least 18 point size.
- Use a simple, sans-serif font, such as Arial or Calibri).
- It is not allowed to use curved text, shadows, or other decorative effects, such as WordArt.

Visual elements:

- Graphic and illustrative materials (photos, drawings, diagrams) should be of high quality and appropriate.
 - Use a variety of slide types: text, images, tables, charts in combination.
 - Avoid overloading slides with information focus on one key message per slide.

Color scheme and style:

- Use no more than three primary colors throughout the presentation..
- The color of text and background should have sufficient contrast for easy reading.
- Avoid excessive use of animations and slide transition effects.

Additional elements:

- Auxiliary elements, such as navigation buttons, should not distract the user from the main content.
 - When using charts and tables, it is important to ensure that:
 - o Diagrams should be clear and easy to understand, with clear labels;
 - o Tables should be minimalistic, with an emphasis on the most important data.
