- 1.2. Consent has been given to allow the processing of personal and other data provided by the User in the forms by filling in appropriate text fields and/or attaching files to the forms. The general categories of data include:
- 1.2.1. Surname, first name, patronymic or middle name, date and place of birth, age, citizenship, identity document details, residence address, current address, city of residence, educational background, email address, contact phone number and any other relevant information provided by the user that can be used to identify them as an individual;
